COALITIONS REPRESENTING THE DISTRICT OF COLUMBIA, THE COMMONWEALTH OF PUERTO RICO, AND EACH OF THE SEVERAL UNITED STATES TERRITORIES SHALL BE ELIGIBLE TO JOIN UNDER THE PROVISIONS OF THIS PART. EACH VOTING MEMBER SHALL BE REPRESENTED BY ONE PERSON WHO HAS BEEN DESIGNATED BY THE MEMBER IN WRITING TO SERVE IN THIS BEHALF.
