Safety Net - Provided training and consultation on the safe use (and prevention of abuse) of technology for victims of domestic violence, sexual assault and stalking. Trained approximately 5,000 practitioners on technology topics, including safe victim relocation, technology and confidentiality, and enhanced victim services through technology. Organized and hosted the inaugural Technology Summit, a 4-day conference bringing together advocates, victim service providers, law enforcement, prosecutors, technologists, and other professionals to address the intersections of technology, safety, and privacy. Launched a new blog, www.techsafety.org, to explore the relationship of technology and privacy with intimate partner violence, sexual assault, and violence against women.

4b (Code:) (Expenses \$ 384,234. including grants of \$) (Revenue \$) Coalition Assistance - Provided training and consultation to the 56 state and territorial domestic violence coalitions, to enable them to better lead efforts to end violence in their states and territories. Hosted a national Roundtable meeting to enhance best practices, provide training and peer education, and share resources, in which 44 coalitions participated. Provided information, support, and resources [technical assistance] to new and interim coalition Executive Directors individually and through regular conference calls. Hosted regional meetings for state and territorial coalitions. Responded to requests for assistance on a wide range of topics, including organizational development, evidence-based practices, crisis-management, trauma-informed care and increasing access to services.

4c (Code:) (Expenses \$ 330,837. including grants of \$) (Revenue \$) Housing - Provided nearly 200 domestic violence transitional housing/shelter programs with training and expertise to support their effective delivery of services. Created an online Transitional Housing Toolkit, an extensive resource center for transitional housing programs (the next step after emergency shelter for survivors), available at http://nnedv.org/thtools. Conducted multiple in-person, national trainings and webinars for transitional housing providers on best practices for serving victims of domestic violence, including topics such as sexual assault & stalking, serving LGBTQ & HIV-affected survivors, serving survivors with disabilities, and working with older survivors. Provided hundreds of hours of individualized technical assistance/consultation to improve their knowledge and services.
