**Position:** Housing Advocacy Coordinator

Responsible To: Rural and Disabilities Projects Manager

**Primary Responsibility:** Work statewide with KCSDV member programs to reduce the disparate impact of co-occurring domestic and sexual violence and homelessness to improve housing and economic stability for survivors. The project will serve survivors who are homeless or at-risk for homelessness due to COVID-19 pandemic. Build collaborative relationships with Kansas Statewide Homeless Coalition and local housing providers and participate on committees related to housing and homelessness (BoS CoC, CE, HMIS, HIC/PIT). Work with KCSDV member programs and allied professionals to strengthen and formalize their collaborations with local housing providers.

## **Specific Duties:**

- Coordinate KCSDVs RRH program.
- Review RRH applications and coordinate with member programs for RRH services.
- Gather and become familiar with information and resources from KCSDV member programs, other state
  coalitions, and national technical assistance providers on the impact Covid-19 has had on homelessness for
  survivors of domestic and sexual violence.
- Become familiar with housing laws and regulations that impact the project and survivors of domestic and sexual violence.
- Evaluate and disseminate trauma-informed, culturally relevant, and racially equitable housing advocacy case management practices.
- Evaluate and implement culturally responsive, trauma-informed financial literacy/ empowerment curricula for use by KCSDV member programs.
- Deliver training to KCSDV member programs on best practices, Rapid Rehousing, Housing First and financial literacy/ empowerment.
- Provide training and technical assistance for KCSDV member programs on building capacity around housing advocacy, financial literacy, and economic justice.
- Deliver training to homeless and housing providers on the dynamics of domestic and sexual violence and trauma-informed responses.
- Provide ongoing technical assistance on issues related to best practices when working with survivors of domestic and sexual experiencing homelessness.
- Ensure reporting requirements for the project are met using a HMIS comparable database.
- Assist with other KCSDV duties as assigned.
