#### **JANUARY**

### **Welcome to the Academy and the Movement**

Your new role as a leader in your organization requires you to be multi-skilled and highly adaptable. This opening session of Directors' Academy will set the stage for developing those qualities as we review the year's content, your relationship with MCADSV and MCADSV's role in addressing complaints made against your program. Learn about your role in Missouri's social movement to end domestic and sexual violence, and then discuss confidentiality laws and how they affect your program's daily activities.

# Your Voice in the Movement: Working with legislators and media

You are now the public face and voice for your organization, so it's time to hone your skills of persuasion and education as you are oriented to Missouri's legislative process and working with media. You'll have the opportunity to visit with your local legislators, then practice being interviewed and return to your program with a press release ready to distribute to your local media about your visit to the capitol and the work being done to end rape and abuse.

This session will help you read your agency's financial statements, create a working budget, prepare for an audit and create high standards of internal controls, no matter the size of your agency.
