
Coalition Membership



Coalition Program Membership

Summary of Results: The maprity of respondents (8 6%) stated that the coalition had stand-alone DV Programs members, with the next largest proportion (76%) with Dual DV/SA Program members. Only 36% of respondents reported that they had stand-alone SA Programs as members, which may have skewed the results since the respondents to this question were a mixture of DV only (61%) and Dual Coalitions (39%). 

Coalition Membership Dues

Summary of Results: Coalitions reported the largest portion of dues was collected from DV/SA/Dual Programs, with an average of \$1300. The next largest dues contribution is dues paid by For-Profit Organizations, averaging \$430, followed closely by Government Agencies at an average of \$370. 




Coalition Transitions

Summary of Results: Half (50%) of respondents stated that the coalition's board had restructured. F urthermore, almost half of coalitions reported having had an ED Transition (43%) in the past 3 years. Additionally, respondents were asked to identify if they only had positions added (20%), only had positions reduced (7%), or had both added and reduced positions (47%) in the past 3 years. 
